- 1. What is the role of diplomacy? What are the players in diplomacy? What are the methods of conducting diplomacy?
- 2. What does environmental diplomacy deal with? Discuss some major post-war global conferences and their impact on the development of environmental diplomacy.
- 3. How does diplomacy contribute to the peaceful settlement of disputes? Discuss the methods of dispute settlement employed in diplomacy. What is the role of the mediator? Explain the distinction between facilitative mediation and evaluative mediation.
- 4. Define the purpose and process of multilateral diplomacy negotiations. What are the factors that shape diplomacy negotiations? What are the topics handled in international negotiations? Which final documents can be adopted in international negotiations?
- 5. What does refugee diplomacy deal with? Discuss the factors that had influence on the emergence and development of refugee diplomacy. Characterize the Office of the UN High Commissioner for Refugees (UNHCR). Distinguish between the following concepts: refugee, migrant, asylum seeker, forcibly displaced persons, internally displaced persons. Who are the actors in humanitarian diplomacy?
- 6. Define the concept of non-governmental organizations, international organizations, intergovernmental organizations and supranational organizations.
- 7. Define the main organs of the UN and the scope of its activities. Name some specialized agencies working with the United Nations.
- 8. Define these forms of government: totalitarianism and democracy. What are the 2 types of democracy? Compare the concept of communism and socialism.
- 9. Discuss the adoption of Universal Declaration of Human Rights. Give its content and structure. Analyse the international conventions protecting human rights at the European level. Define the concept of human rights. Define humanitarian principles. Give examples of international humanitarian organisations/movements.
- 10. Vienna Convention on Diplomatic Relations adoption of the convention, nuncio, diplomatic personnel, distinction between the Vatican City and Holy See, daily activities of a diplomat, charge d'affaires ad interim, charge d'affaires en pied, the letter of credence
- 11. Vienna Convention on Diplomatic Relations persona non grata (example), privileges and immunities of the diplomatic mission (head of the mission, family members, diplomatic bag, premises, courier...), inviolability of diplomatic premises
- 12. Vienna Convention on Consular Relations adoption of the convention, consular functions, consular titles, appointment of consuls, consular immunities and privileges, end of consular functions
- 13. Diplomatic correspondence different types of notes: aide-memoire, note verbal, collective note, identical note, exchange of notes, full powers, letter of credence, exequatur, letter of recall
- 14. Diplomatic protocol before arrival, arriving at the post, making calls, hierarchy, foreign service grades, courtesies, host country culture, official events, dress code
- 15. Introduction to law, the doctrine of division of powers (legislative power, executive power, judicial power)
- 16. Compare the judicial method of solving disputes to alternative dispute resolution
- 17. Family law and law of succession
