The session will briefly present the new opportunities for synergies between Horizon Europe and other EU funding programmes, with a specific focus on synergies between Horizon Europe and Erasmus+.

#### 10:10 – 10:40 Horizon Europe: missions

One of the main novelties in Horizon Europe is the mission-oriented approach to urgent but diffuse problems, such as climate change, cancer and achieving carbon neutrality. The missions should be relevant to a broad range of stakeholders and to citizens should be completed using a bottom-up approach. Once fully up and running, the five missions will largely be financed by the second pillar of Horizon Europe. During the first three years of Horizon Europe, the missions will get up to 10% of the annual budget of this pillar. The session will be dedicated to the general introduction of five future missions with the specific focus on their implementation.
